IRS Data Retrieval Tool (DRT) Notes:

1. If you file electronically, your tax information will be available for import into your FAFSA within 14 days of filing. If you filed a paper return, it may take four-six weeks before your tax information is available for import.
2. If you are married filing separately, you are not eligible to use the DRT. You and your spouse must request your Tax Return Transcripts from the IRS.
3. If you amended your tax return, you are not eligible to use the DRT. You must request your Tax Return Transcript from the IRS and submit it to GSC along with a signed copy of your 1040X.
